1. Welcome/Karakia/Apologies

Lincoln University moved up two places in the Times Higher Education (**THE**) rankings. These rankings have a lag factor as they are based on 2019 performance.

7.1 Monthly Health and Safety Report

Critical research activities and construction were recommenced in Level 3.

The University has requested all contractors wear masks when moving around the campus.

New Zealand Universities and CRIs are working together around the WorkSafe guidance relating to hazardous substances. If changes are required, they could come at a significant capital and/or operational cost.

Council requested the report provide more information on near misses in future and directed the Health and Safety and Campus Development teams to work closer together to ensure consistent reporting and messaging.
