7. Vice-Chancellor's Report

The report was taken as read and NOTED.

The Vice-Chancellor gave an update on the Covid vaccination survey, noting 90.4% of the staff indicated they were planning on getting vaccinated and only 9.5% said that they had no plans on getting fully vaccinated.

Kate Flower and Peter Harris have resigned, and an interim has been appointed in Peter Harris's place. The recruitment process for a permanent replacement is underway with Branigans, with the hope to have the replacement start February 2022.

A new 'rainbow' pedestrian crossing has been installed.

The 2021 Blues and Golds Awards were celebrated this year. The event featured contributions from prominent alumnus Sam Bosworth and Dr Hafsa Ahmed. Blues and Golds winners included new Tall Fern Lauryn Hippolite (Sportsperson of the Year), Amy Wells (Gold Award for Service Excellence) and LU premier netball team (Team of the Year).

Lauren Waller and Naomi Wells were awarded Te Pūtea Rangahau a Marsden | Marsden Fund grants to pursue their research projects.

Te Whaihanga was announced as the winner of an Outstanding Planning Achievement award at the 2021 Commonwealth Association of Planners (CAP) Awards.

Professor Don Kulasiri and former PhD student Rahul Korsarwal, jointly authored monograph Chemical Master Equation for Large Biological Networks.

More than 30 student researchers attended the Lincoln's Postgraduate Conference, a little smaller than previous years.

A team of four Lincoln students claimed third place in this year's International Food Marketing Challenge. The commercialisation of these sort of achievements was discussed and the IP was noted as sitting with the student.

Professor Grant Edwards and Zero Invasive Predators Chair Devon McLean signed a collaborative partnership between Lincoln University and ZIP for a further four-year term.

Emeritus Professor Keith Cameron, Professor Hong Di and Professor Richard McDowell, have been named in this year's Royal Society Te Apārangi Research Honours Awards list.

Professor Keith Cameron and Professor Hong Di have been awarded the Pickering Medal for their invention of ClearTech.

Professor McDowell won the Hutton Medal: The Royal Society Te Apārangi's oldest medal.

Sixteen Manaaki New Zealand Scholarship students representing ten countries received Completion Certificates from the Acting Vice-Chancellor on 28 October.

Lincoln University and one of its key agents, Pacific Education Alliance Ltd (PEAL), are joining forces with six Canterbury secondary schools to form an international recruitment alliance.

7.1 Monthly Health and Safety Report

7.1.1 Bio-Compliance Supplementary report

The University's process picked up three of the four non compliances. Noting these were picked up at the final hurdle.

The researcher did not check the unwanted organism register as part of the process.

Tracey Nelson has flagged the resourcing issue and that it was a system slip but the processes in place, managed to highlight them. The Deputy Vice-Chancellor added that the key take out from this is education for staff members and students. Tracey Nelson and the Deputy Vice-Chancellor will work on this to educate staff on the process. Committee requested this be part of the internal audit and be provided to ARC. Tracey Nelson confirmed there is a breach register for Bio-Compliance and Health and Safety.

8. Academic Board Report

The report was NOTED.

The Academic Board met for the final time this year on Wednesday 17 November.

A total of nine new courses were approved, a combination of core and electives, for the Master of Applied Computing, the Graduate Diploma and BSc major in Brewing and Fermentation, and the Bachelor of Commerce (Horticulture).

The Academic Dates Working Group presented a recommendation for the 2023 academic calendar which removes the overlap between the end of Semester 2 and the start of November Summer School, and this was approved by the Board.
